FRA Asked To Take Federal Lead For Altamont Corridor

Authority Staff has engaged the Federal Railroad Administration (FRA) regarding becoming the federal lead agency for the Altamont Corridor Rail Project environmental review process (the Authority is the lead state agency). This proposed joint-use rail project will complement the Authority's proposed HST network. At the request of the FRA, a "Project Justification" for the Altamont Corridor Rail Project was developed and submitted (08/03/2009) along with the transmittal requesting that they become the lead federal agency.
